### I. WHY SHARED GOVERNANCE? WHY SERVE FOR OUR FACULTY?

Why Do We Advocate for Shared Governance? Why Do We Serve Our Faculty? Yueh-Ting Lee, Ph.D., Professor of Psychology, Faculty Senate President

In American higher education, shared governance has become a part of institutional or organizational culture. On July 15, 2021, as the Faculty Senate President, I gave my first, but brief, presentation at the meeting of our SIU Board of Trustees about what we meant by shared governance. Shared governance means accountability/responsibility, communication and collaboration, transparency and respect. We are all held accountable and responsible for our words, actions or decisions, including the elected governor, (who appoints) the Board of Trustees, (who appoints) the president, chancellors, (who appoint) other administrators (deans, chairs/directors to whom the faculty report). Faculty members are held accountable as well. While we may disagree on certain issues, we agree to disagree and must be willing to collaborate with others to work toward realization of the same university mission and strategic directions. Communication (information sharing) and transparency help to build trust. This is independent of one's status in academia. It does not matter whether we are administrators, faculty, staff, or students. We should respect each other. Part of our purpose here is to serve for students, as well as, members of the community at large.

Why do we Faculty Senators serve our faculty? There is a transient nature to the academic environment where students come and move on to careers once they graduate; administrators will sometimes leave their administrative roles or move to a new university. Still many faculty stay at an institution such as ours to build and foster their own careers. Further, faculty members play the most important role in our student success, institutional reputation, knowledge dissemination and productivity, research/creativity, discovery, and local and global community engagement. Faculty Senate is the legitimate body to advocate for shared governance, for the faculty's interest and welfare, budget, university curricular and academic policies, and other university-related important business matters.

Two important notes are in order with respect to serving for the faculty. First, it has been approximately 60 years since SIU Carbondale's Faculty Senate began. To reiterate, it is the legitimate constituency for our faculty with the longest history at SIU. I am very honored and humbled to serve as the FS president. I believe in servant leadership, shared governance, student success and faculty

excellence. I strongly advocate for the faculty's interest and welfare and surely support the University's mission and strategic goals.

As a second note, I wish to express my great appreciation to Dr. Bethany Rader, an associate professor in microbiology, for her outstanding service to our Faculty Senate in the past years. Dr Bethany did an excellent job as the FS vice president while I served as the FS president in 2021-2023. During 2023-24, she did a fantastic job as the FS president.
